The Board explained that it believes just cause may exist to support the termination based upon the following factors: inadequate goals and objectives, unapproved and unauthorized costs expensed to the college, policy violations, renovations to the president's office, her planned inauguration, purchase of a chain of office medallion, improper management behavior, improper comments, and lack of professionalism. The Board will make a final determination regarding President Spielvogel's employment during a Special Meeting which has not yet been scheduled.

MOTION by Dr. Lindley, with support by Mr. Small to move that after reviewing the information provided there is sufficient information to find that just cause exists to support Ms. Spielvogel's termination pending the final determination at a just cause hearing before the Board. Dr. Spielvogel is suspended with pay pending the final determination. The college attorney is directed to send written notice of the Board's intention to make a final determination.
