Mr. Schaffer updated the Board on the following:

- West Campus Project the soccer, baseball and softball fields are ready for use. Students are currently practicing on the fields.
   A field dedication will occur on September 20, 2025.
- Jenkins Theatre the college has moved to a rental model for the Jenkins Theatre. We currently have four shows booked for this upcoming year. The college is in negotiations to add a few more shows to the lineup. Mr. Schaffer praised the work of the Facilities team, Laura Kraklau in Marketing and Bailey Hermann in Facilities for all their work to make shows happen.

# <u>Proposed Contract Between Lake Michigan College and Kinexus</u> <u>Group</u>

Lake Michigan College seeks Board pre-approval to enter into a contract with Kinexus Group for the development and expansion of apprenticeship and pre-apprenticeship programming aligned with regional workforce needs.

#### Contract Term:

- Initial Term: July 1, 2025 December 31, 2026
- Extension Clause: The agreement may be extended upon mutual consent based on performance, expanded duties, and availability of funding. Any extensions would include revised budget allocations and updated deliverables.

# Scope of Work:

- Under this contract, Lake Michigan College will provide curriculum and platform development services, including:
- Creation of three new Registered Apprenticeship Programs (RAPs)
- Expansion of three existing RAPs
- Creation of three new Pre-Apprenticeship programs
- Expansion of three existing Pre-Apprenticeship programs
- Target industries include Viticulture, Agricultural Production, and Project Management
- Programs will incorporate stackable credentials to support career pathways and workforce advancement.

### Strategic Alignment:

This partnership supports LMC's workforce development mission and strengthens its role in preparing students for in-demand careers. It also reinforces existing collaborations with Kinexus and promotes economic growth through credentialed training in critical regional sectors.

**Action:** It is recommended that the Lake Michigan College Board of Trustees approve the reimbursable cost provision within the proposed contract between Lake Michigan College and Kinexus Group, with total reimbursable expenses not to exceed \$104,175.
