PRESIDENT'S REPORT

Dr. Kubatzke began his report by welcoming and introducing several new members of the Lake Michigan College community:

Following the introductions, Dr. Kubatzke proudly announced that *SmartAsset* has ranked Lake Michigan College as the **#1 community college in Michigan** and **#13 nationally**. The ranking was based on key factors such as affordability, student retention, and faculty-to-student ratio. A press release highlighting this achievement will be distributed to media outlets on Wednesday, September 17, 2025.

Dr. Kubatzke also provided an update on the upcoming millage proposal and revisited the topic of the Niles campus sale. He noted that Berrien County currently lacks a dedicated vocational/technical center. In response, LMC has partnered with the local the Chamber of Commerce and Berrien RESA to establish a facility designed for high school apprenticeship programs. This collaboration allows LMC to use the space at no cost while continuing to offer classes on-site.

Additionally, on September 15, 2025, Dr. Kubatzke, along with Al Pscholka, Jennifer Shoemaker, Dr. Ken Flowers, Charmae Sanders, and Immanuel Williams, attended a Benton Harbor City Commissioners meeting. During the session, the group shared highlights of LMC's history, recent accomplishments, and details about the two millage proposals on the November ballot. The presentation was well received, and the commissioners expressed their support for the college.

NEW BUSINESS

Community College Local Strategic Value Resolution

Section 230 of PA 103 of 2023, the Fiscal Year 2025 community colleges appropriations bill contains the qualifications that must be met to receive the portion of each college's performance funding appropriation earmarked for local strategic value. The statute lists 15 separate best practices for community colleges to achieve. Institutions must satisfy 4 of 5 best practices in each of 3 different categories.



To demonstrate eligibility for this funding, Section 230 requires that each community college certifies compliance to the State Budget Office by means of a board of trustees resolution certifying that the college has met 4 of 5 best practices in each category. Further, each board resolution "shall provide specifics as to how the community college meets each best practice measure within each category."

ACTION: It is recommended that the Lake Michigan College Board of Trustees approve the following resolution, as presented, which provides specifics as to how Lake Michigan College meets the best practice measures within each category to prove its Local Strategic Value for the region it serves.
