# Accreditation

---

## Program Accreditation

Graduation from a physical therapist assistant education program accredited by the Commission on Accreditation in Physical Therapy Education (3030 Potomac Avenue, Suite 100, Alexandria, VA 22305; 703.706.3245; [accreditation@apta.org](mailto:accreditation@apta.org)) is necessary for eligibility to sit for the licensure examination, which is required in all states. Candidacy is considered to be an accredited status, as such the credits and degree earned from a program with Candidacy status are considered, by CAPTE, to be from an accredited program. Therefore, students in the charter (first) class should be eligible to take the licensure exam even if CAPTE withholds accreditation at the end of the candidacy period. That said, it is up to each state licensing agency, not CAPTE, to determine who is eligible for licensure. Information on licensing requirements should be directed to the Federation of State Boards of Physical Therapy (FSBPT; [www.fsbpt.org](http://www.fsbpt.org)) or specific state boards. A list of state boards and contact information is available on FSBPT's website.

Lake Michigan College (LMC) is seeking accreditation of a new physical therapist assistant education program from CAPTE. The program is planning to submit an Application for Candidacy, which is the formal application required in the pre-accreditation stage, on May 1, 2026. Submission of this document does not assure that the program will be granted Candidate for Accreditation status. Achievement of Candidate for Accreditation status is required prior to implementation of the professional phase of the program; therefore, no students may be enrolled in professional courses until Candidate for Accreditation status has been achieved. Further, though achievement of Candidate for Accreditation status signifies satisfactory progress toward accreditation, it does not assure that the program will be granted accreditation. If the program does not achieve accreditation after Candidacy status, LMC is committed to supporting enrolled students with a transition plan and academic counseling to help them pursue alternative educational pathways. Preliminary agreements with regional accredited PTA programs will facilitate transfer opportunities, pending students' completion of all admission requirements and application processes.

## What is a Physical Therapist Assistant?

---

A physical therapist assistant (PTA) is a licensed healthcare professional who provides direct patient care, helping people improve mobility, reduce pain, and restore function following injury, illness, or surgery. PTAs work collaboratively with physical therapists to implement comprehensive treatment plans, performing hands-on interventions such as:

- Therapeutic exercise
- Gait and mobility training
- Balance activities
- Manual therapy techniques
- Pain management techniques
- Physical agents and modalities (heat, cold, ultrasound)
- Patient education

PTAs work in diverse healthcare settings, including hospitals, outpatient clinics, rehabilitation facilities, skilled nursing facilities, home health agencies, sports medicine clinics, and schools. This variety allows PTAs to specialize in areas aligned with their interests and skills, whether working with athletes, children, the elderly, or individuals recovering from specific conditions or injuries. PTAs often explore different settings throughout their careers, gaining broad experience in physical therapy.

The **career outlook** for PTAs is strong, particularly in Southwest Michigan where growing healthcare needs drive demand for rehabilitation services. According to the U.S. Bureau of Labor Statistics, employment of PTAs is projected to grow 25% from 2023 to 2033, much faster than the average for all occupations. The median annual wage for physical therapist assistants was \$65,510 in May 2024, with the top 10% earning \$87,630 or more per year.

## Considering a Career as a PTA

---

If you're interested in a healthcare career that combines science, movement, and meaningful connection with others, a career as a PTA could be an excellent fit. This path may be a strong match if you:

- Are compassionate and enjoy helping others
- Have an interest in health, wellness, and exercise
- Prefer active, hands-on work
- Enjoy working with people of all ages and backgrounds
- Communicate and collaborate effectively
- Are detail-oriented and manage time well

## Program Overview

---

Lake Michigan College will launch its PTA Program in **Fall 2027** at the South Haven campus. Each year, up to 18 students will be accepted through a competitive selection process for fall entry. All application requirements, including general education and prerequisite courses, must be completed and submitted by the May 12 deadline to be considered for admission.

The professional program is four semesters long and delivered in person to support hands-on learning and personalized instruction. The curriculum integrates classroom instruction with laboratory practice and real-world clinical experiences in various healthcare settings.

Graduates will earn an Associate of Applied Science (AAS) degree and become eligible to take the National Physical Therapy Examination (NPTE), which is required for licensure as a PTA. Program outcomes, including graduation rates, licensure exam pass rates, and employment data, will be published on the PTA Program website as they become available.

## Preparing for Success

---

**Build a strong foundation:** Strong performance in your prerequisite courses is essential for success in the PTA Program. These courses provide the foundational knowledge you'll build on throughout the curriculum and are heavily weighted in the application ranking process. To support your success, we encourage you to explore the College's academic, financial, and student support services available on the [MyLMC website](#).

**Gain hands-on healthcare experience:** Working in a direct patient care role (such as PT tech, CNA, or medical assistant) helps you build valuable skills, explore your career interests, and gain insight into the healthcare field. This experience strengthens your readiness for the PTA Program. Qualifying experience also adds 5 points to your application score.

## Application Requirements

---

*Ready to apply?* All requirements listed below must be completed and submitted by the May 12 deadline. While all items are required, some are also used to determine applicant rankings. Details are provided in the *Application Scoring* section of this guide. Students are encouraged to begin preparing early to ensure all materials are submitted on time.

### General Admission Requirements

1. Be at least 18 years old before starting the PTA professional program.
2. Be a high school graduate or successfully complete the GED test.
3. Submit a [Lake Michigan College Application for Admission](#).
4. Send all official transcripts from high school and colleges previously attended to the LMC Records and Registration office at [records@lakemichigancollege.edu](mailto:records@lakemichigancollege.edu).

## Technical Standards and Essential Functions

The PTA Program and physical therapy profession require specific physical, cognitive, and interpersonal capabilities. Students must be able to perform these essential functions to be successful in both the program and profession. See Appendix A for a complete list of these requirements. Students with disabilities may be eligible for accommodations to meet these requirements. Contact [Disability Support Services](#) to discuss individual needs.

## Required Coursework

All prerequisite and general education courses must be completed by the application deadline. Courses must also meet minimum grade, GPA, and timeframe requirements as outlined below.

For questions about transfer credits or course substitutions, please consult your advisor and review your DegreeWorks plan in your Student Profile.

If you retake BIOL 110, HEAL 103, or EXSC 208, one point will be deducted from your total application score for each retake. Withdrawals do not result in point deductions.

## PTA Program Information Session

All applicants must attend a PTA Program Information Session within 18 months of the application deadline. Sessions are held in the PTA lab (Room 220) at the South Haven Campus on the second Tuesday of February, April, August, and October from 4:00 to 5:00 PM, beginning February 2026.

During the session, you will receive a program overview, meet faculty, tour the PTA lab, and learn more about the admission process.

Advance registration is required. To register, [complete the online form](#). If you are unable to attend a scheduled session, individual appointments may be arranged upon request.

## ATI TEAS

The ATI Test of Essential Academic Skills (TEAS) must be completed within 2 years of the application deadline. There is no minimum required score; application points are awarded based on your total TEAS score. Multiple attempts are allowed, with a mandatory 30-day waiting period between tests.

Adequate preparation is strongly recommended, as your TEAS score directly impacts your application ranking. Study resources include [ATI’s official TEAS materials](#) and free resources available through the [College Library](#). Additional free practice tests and study tools are widely available online.

### **Physical Therapy Observation Hours**

You must complete 20 hours of physical therapy observation under the supervision of a licensed PT or PTA within two years of the application deadline. While all hours may be completed at a single facility, we encourage exploring different settings (e.g., outpatient clinics, hospitals, rehab centers) to gain broader insight into the field. If you currently work as a PT aide or tech providing direct patient care, those hours may count toward this requirement. Administrative or non-clinical roles do not qualify.

A verification form must be completed by the supervising PT or PTA for each site. For detailed instructions and required documentation, see Appendices A and B in this guide.

### **Direct Patient Care Work Experience (Optional)**

Direct patient care work experience is optional but can strengthen your application and provide valuable insight into the healthcare environment. Applicants who complete at least 100 hours in a qualifying role will earn 5 points toward their application score. Qualifying roles involve hands-on patient care and include PT Aide/Tech, CNA, Medical Assistant, Nursing Assistant, Resident Care Assistant, and similar positions. Administrative or clerical roles do not qualify.

To receive credit, submit a letter from your employer on company letterhead verifying your role and confirming completion of a minimum of 100 hours. The letter must include supervisor contact information. If you're unsure whether your experience qualifies, contact the Health Sciences Office for guidance.

- Be at least 18 years old before starting the program
- Meet technical standards and essential functions for safe patient care (see Appendix A)
- Apply to Lake Michigan College and submit official transcripts from all colleges and high school/GED
- Complete all prerequisite and general education courses within required timeframes, meeting minimum grade and GPA standards
- Attend PTA Program Information Session within 18 months of application deadline
- Complete ATI TEAS within 2 years of application deadline; arrange for official scores to be sent to LMC if taken remotely or at another institution
- Complete 20 hours of physical therapy observation within 2 years of application deadline with required observation form(s)
- Submit the following to the Health Sciences Office by the May 12 deadline:
  - Program Application Form
  - Physical Therapy Observation Form(s)
  - Employer verification of qualifying healthcare experience (if applicable)

## Application Submission and Deadline

---

Submit application and required documents by **May 12th at 5:00 PM** to the Health Sciences Office in person, by email, or by mail (must be postmarked by deadline). If the deadline falls on a weekend or holiday, submissions are due by the preceding business day. Late or incomplete applications will not be considered.

## Application Scoring

---

### Application Points

Applications are evaluated using a 100-point system, with points earned according to the criteria below. Your final score will be your total points minus any deductions for course retakes.

## Calculate Your Estimated Score

The [Application Checklist and Points Calculator](#) is an interactive tool that helps you track your progress toward program requirements. Based on the information you enter, it will:

- Show you any remaining requirements you need to complete
- Calculate your estimated point total
- Alert you if grades don't meet minimum GPA or course grade requirements

Use this tool to stay organized, monitor your progress, and better understand how your efforts impact your application. For best results, use a desktop or laptop.

This tool is for personal use only. Information entered in this tool is not saved or submitted. Official points will be calculated using your academic records, transcripts, and other application materials.

## Understanding Your Application Score

Your total points reflect the strength of your application based on our published criteria. While we cannot provide specific score thresholds for admission (as these vary each year based on the applicant pool), we encourage all qualified candidates to apply. Admission is competitive and based on the highest-scoring applications we receive. Successful applicants typically demonstrate strength across multiple categories rather than excelling in just one area. Focus on presenting your best possible application rather than trying to predict admission likelihood based on points alone.

## Selection Process

---

The 18 candidates with the highest total points will be offered admission for fall enrollment. In the event of a tie, the prerequisite GPA will serve as the primary tiebreaker, followed by the ATI TEAS total score and general education GPA if needed. All applicants will be notified of their admission status via email by June 15. Admitted students must confirm their seat by the deadline provided in their admission notification and attend the mandatory PTA Program Orientation held in August prior to fall classes. Specific orientation details will be provided with admission materials. Applicants who are not admitted may reapply during the next spring application period. The program does not maintain a waitlist.

## Program Course Sequence

---

Once admitted to the PTA Program, students will complete the following professional courses in sequence. The program includes three Clinical Education courses (I, II, and III), requiring full-time clinical experiences of 4 weeks, 6 weeks, and 8 weeks respectively.

## Program Expectations

---

The PTA program maintains high standards to prepare students for entry-level practice. Students must follow all policies outlined in both the [College Student Handbook](#) and PTA Program Handbook, which is provided upon acceptance. The following highlights key program requirements and expectations.

### Academic and Performance Standards

A minimum grade of 77% (C+) is required for final course grades, written exam averages, and skill assessments. Faculty provide individualized support to help students meet these requirements. The College offers additional resources including tutoring, writing assistance, and disability support services.

### Professional Expectations

Students must consistently demonstrate professional conduct, including punctuality, preparedness, accountability, respect, and integrity in all interactions. Students are expected to maintain a positive attitude

and contribute constructively to the learning environment. This includes taking initiative, welcoming feedback, and demonstrating a growth mindset when facing challenges. Students must also engage respectfully with individuals from all backgrounds, recognizing that varied perspectives and experiences enrich the learning environment. This commitment to diversity and inclusion prepares students to provide individualized, compassionate care in clinical practice.

## **Hands-on Learning**

Hands-on patient care is fundamental to the physical therapy profession. In the PTA Program, students gain practical experience through hands-on learning in both lab and clinical settings. In lab, students alternate roles as clinician and patient while practicing techniques and providing peer feedback. Students then apply these skills with actual patients under direct supervision in clinical settings. Students must be comfortable with appropriate physical contact necessary for patient care, such as transferring patients, assisting with mobility, guiding exercise, and performing manual techniques. Students should also be prepared to encounter bodily fluids and manage medically complex situations in a variety of healthcare settings. All interactions must be conducted with the utmost professionalism, respect for patient dignity, and strict adherence to therapeutic boundaries.

## **Attendance and Scheduling**

Attendance is mandatory for all class, lab, and clinical sessions. Students are allowed a total of 40 hours of excused absence, reserved strictly for unplanned personal emergencies or illness. These hours are not intended for discretionary use and must be taken in 4-hour (half-day) or 8-hour (full-day) increments. Documentation may be required, and excessive absences may impact academic progress and program completion.

Students participate in 20–25 hours per week of scheduled activities, including lectures, labs, and open lab sessions, typically held four days per week. Occasionally, required activities may be scheduled outside of regular hours with advance notice. Clinical experiences require full-time attendance (40 hours/week).

## **Dress Code**

Students must maintain a professional appearance throughout the program. In lab sessions, appropriate athletic attire is required to allow movement and hands-on practice. Some activities may involve exposure of specific body areas, so clothing that permits access, such as a tank top or shorts, may be necessary. For clinical education experiences, students must follow the facility's dress code. If no specific dress code is provided, students are expected to wear the program polo with business casual attire. Students with religious, cultural, or personal concerns about lab or clinical attire should consult with program faculty to discuss accommodations.

# Clinical Compliance

---

## Compliance Requirements

Healthcare facilities establish health and safety requirements to protect both patients and healthcare providers. While Lake Michigan College does not set these requirements, the program must ensure students meet them to participate in clinical experiences. The requirements listed below are standard for all clinical sites. Individual sites may have additional requirements. Detailed instructions and completion deadlines for these requirements will be provided upon admission to the program.

1. Criminal background check and drug screen
2. Health certification form completed by healthcare provider
3. Required immunizations:
  - a. MMR (Measles, Mumps, Rubella)
  - b. Hepatitis B
  - c. Varicella
  - d. Tdap (within 10 years)
  - e. Annual influenza
4. Two-step TB screening or blood test, with annual updates
5. Basic Life Support (BLS) Provider or BLS Healthcare Provider RQI certification from the American Heart Association (must remain current)
6. Personal health insurance
7. Reliable transportation (may travel up to 75 minutes to clinical sites)

## Compliance Tracking

Students must purchase access to Complio, a compliance tracking system, to submit and maintain required health records and documentation. All health records and documentation must be kept current throughout the program. Detailed instructions will be provided upon acceptance.

## Exemptions

Students may request exemptions from specific immunization requirements. Since clinical sites establish these requirements, they have sole authority to approve or deny exemption requests. While the program will make reasonable efforts to identify clinical sites that accept exemptions, available sites are limited and placement cannot be guaranteed. If clinical placements cannot be secured or if students cannot meet site requirements, they will be unable to complete required clinical experiences and therefore cannot complete the program.

To begin the exemption process, accepted students must contact the Health Sciences Office to obtain the Immunization Exemption Form and schedule a meeting with the PTA Program Director and/or Director of Clinical Education.

## Program Cost

---

The following costs reflect estimated expenses for the 4-semester professional PTA Program, which includes a total of 76 contact hours. Tuition is billed per contact hour according to the College’s current tuition rates. For the most up-to-date rates, [visit the LMC Tuition and Fees page](#).

### Financial Support

Many students significantly reduce their out-of-pocket costs through financial aid, scholarships, and state programs like the Michigan Community College Guarantee, which offers free in-district tuition and reduced out-of-district tuition for eligible students. LMC programs may also provide free textbooks to qualifying students. Visit the [Financial Aid website](#) for details.

Those experiencing financial hardship are encouraged to contact the Health Sciences Office early to learn about additional support resources.

After graduation, students should plan for approximately \$900–\$1,000 in licensure-related expenses, including the National Physical Therapy Exam (NPTE), state jurisprudence exam, fingerprinting, and initial licensure.

## Residence Hall Housing

---

Students can live in the College’s residence halls at the Benton Harbor campus, which is a 30-minute drive from the PTA Program location at South Haven. Housing options start at \$5,500 per academic year, providing an affordable alternative to apartment living. Students can choose from triple-occupancy suites to single rooms with varying layouts. # Frequently Asked Questions

---

## **What's the difference between a PT and PTA?**

PTs and PTAs have distinct roles and educational requirements. PTs complete a doctoral degree (DPT) and perform patient evaluations, determine diagnoses, develop treatment plans, and supervise care. PTAs complete an associate degree and work under PT supervision to implement treatment plans, provide direct patient care, and document progress. PTs and PTAs work collaboratively as part of the broader healthcare team to support each patient's rehabilitation goals and recovery.

## **How much time should I dedicate to studying?**

The PTA Program is academically rigorous. While study time varies by individual, most successful students dedicate approximately 2 hours per credit hour each week to review course material, practice lab skills, complete assignments, and prepare for exams. For a typical 12-credit semester, this translates to about 24 hours of weekly study time. Strong time management and consistent study habits are essential for success.

## **Can I work while in the program?**

While enrolled in the PTA Program, many students maintain part-time employment. However, due to the program's intensive coursework and clinical requirements, we strongly recommend limiting work hours to no more than 12 hours per week and seeking flexible employment that accommodates academic commitments. Working more than the recommended hours while in the program significantly impacts academic success and is strongly discouraged.

## **How are clinical placements determined?**

The Director of Clinical Education works closely with students to coordinate clinical experiences in diverse healthcare settings, ensuring exposure to different patient populations and treatment approaches. While we consider student interests and location preferences during placement, our primary goal is providing valuable learning experiences that develop well-rounded clinicians.

## **What career advancement opportunities are available for PTAs?**

PTAs have numerous paths for professional growth and career advancement. PTAs can enhance their clinical expertise through continuing education courses and specialized certifications. Clinical opportunities include pursuing APTA's Advanced Proficiency Pathways in eight specialization areas such as pediatrics, geriatrics, oncology, and orthopedics. Leadership roles are available in clinic management, department supervision, and healthcare administration. PTAs can also pursue careers in education as clinical instructors, program faculty, or academic coordinators. Additionally, many PTAs advance their education through bachelor's degree completion programs in health-related fields, with some later pursuing Doctor of Physical Therapy (DPT) programs to become physical therapists.

# Appendix A: Technical Standards and Essential Functions

---

The following capabilities are required for success in the PTA Program and profession. Students with disabilities should contact Disability Support Services to discuss potential accommodations.

## Physical and Motor Functions

- Perform physical tasks necessary to support patient care including standing, walking, bending, and patient handling within safe limits
- Demonstrate sufficient manual dexterity for patient care tasks
- Apply therapeutic techniques with appropriate force and precision
- Operate therapeutic equipment, modalities, and assistive devices safely and effectively
- Respond promptly and appropriately to emergency situations
- Navigate clinical environments safely around equipment and obstacles

## Sensory and Observational Functions

- Observe and monitor patient movement, posture, and responses from various distances
- Identify changes in patient status including physical appearance, movement patterns, and tissue changes during interventions
- Recognize and respond to non-verbal communication and behavioral cues
- Detect and respond to patient communications, equipment alerts, and emergency signals

## Communication Functions

- Exchange information effectively with patients, families, and healthcare professionals
- Comprehend and convey complex information in written and spoken English
- Document patient care accurately and legibly using electronic or written records
- Adapt communication methods to meet the needs of diverse individuals

## Cognitive Functions

- Process, retain, and apply complex information required for patient care
- Analyze, reason, and make sound decisions in academic and clinical settings
- Implement and adjust treatment plans based on patient response
- Adapt to changing clinical environments and situations

## Behavioral and Professional Functions

- Maintain emotional stability, resilience, and professionalism in challenging situations
- Demonstrate respect, empathy, and cultural sensitivity with individuals from diverse backgrounds
- Collaborate respectfully within healthcare teams to achieve shared goals
- Recognize personal limitations and seek appropriate assistance
- Uphold integrity, honesty, and responsibility in all program activities
- Adhere to ethical and legal standards of the physical therapy profession

# Appendix B: Guide to Completing Physical Therapy Observation Hours

---

## Introduction

Observation hours provide valuable insight into the physical therapy profession and help confirm your career choice as a PTA. While you may complete all hours in one setting, we encourage observing across different healthcare environments to gain broader exposure to patient care. Approach each opportunity with enthusiasm, professionalism, and a genuine desire to learn, as the impressions you make and insights you gain could influence your future career.

## Requirements

- Complete 20 hours of observation under a licensed PT or PTA.
- Hours must be completed and documented within 2 years of application deadline.
- Complete an Observation Form for each facility where you conducted observations.
- Current PT aide/tech work hours qualify (document using Observation Form).

## Finding Observation Opportunities

You will need to contact physical therapy facilities (outpatient clinics, hospitals, rehabilitation centers, or skilled nursing facilities) to request observation opportunities. Consider asking family and friends if they know any PTs or PTAs who might be willing to help. Start this process early, as some facilities (especially hospitals) have additional requirements and longer approval processes before observations can begin.

When contacting clinical sites, introduce yourself as a student preparing to apply to the LMC PTA Program and request observation hours. Be professional, polite, and respectful in all communication, as this reflects on both you and the program. You can reach out in various ways:

- **Phone:** For hospitals or skilled nursing facilities, request to be connected to the physical therapy department first. Ask to speak with the person who coordinates student observations. If that person is unavailable, ask for their name and the best time to reach them.
- **In-Person:** Dress professionally and have your contact information (name, phone number, email) written down to leave with the facility. Visit during mid-morning or mid-afternoon, when clinics are typically less busy.
- **Email:** Use formal greetings (Dear Dr./Mr./Ms.) and professional closings (Sincerely, Thank you). Include your full name, contact information, and clearly state your request for observation hours.

Be flexible with scheduling to accommodate the clinic's availability. If you don't receive a response within a week, follow up politely. Remember that clinics are busy healthcare environments, so patience and professionalism are essential.

## Professional Conduct During Observation

Professional behavior is required during your observation; hours will not count toward your application if professional conduct standards are not met. Students must demonstrate:

- **Professional appearance:** Wear clean business casual attire with comfortable closed-toe shoes, unless the facility specifies otherwise. Maintain good hygiene. Keep hair neat and secured if long. Minimize jewelry and avoid strong fragrances.
- **Punctuality:** Arrive 15 minutes early and stay for your entire scheduled time.

- **Respect:** Be courteous and mindful of others. Follow staff instructions, maintain appropriate boundaries, and protect patient privacy.
- **Engagement:** Stay attentive throughout your observation. Keep your phone silenced and stored away.
- **Communication:** Use appropriate language and tone when speaking with staff and patients. Listen attentively and ask questions when appropriate.

Use this opportunity to learn about physical therapy treatments and terminology. During downtime, you may offer to help with basic non-clinical tasks, such as folding linens, straightening treatment areas, or organizing equipment.

Thank each patient after their session and thank staff before departing. A simple "thank you for allowing me to observe" is appropriate. Ensure your Observation Form is completed and signed by your supervising PT/PTA before leaving.

### **After the Observation**

Send a thank-you email to your supervising therapist within 48 hours of your observation. Include specific things you learned and express appreciation for the opportunity. Remember, these clinics may be your future employers or colleagues – a thoughtful thank-you helps build your professional network.

Make a copy of your signed Observation Form for your records, then submit the original to the Health Sciences Office. Be sure all required fields are complete, including signatures and dates, before submission.
